We acknowledge and accept that if we evade concluding the Contract of Sale or paying the full price by the date specified in the Contract, the Seller has the right to retain the tender deposit paid by us in full.
7. We bear all costs and expenses related to the preparation and submission of the subject bid and our participation in the tender on our own, and we acknowledge that these costs will not be reimbursed by the Seller to any extent.
