The objective of the project is to ensure reliable and fully automated print quality inspection, improve defect detection capabilities, and enhance the overall stability and efficiency of the production process. The new vision inspection systems will be responsible for print quality control, detection of production defects, and real-time monitoring of critical process parameters. The scope of the project includes delivery, installation, commissioning, and training of operating personnel.
